
#### Marine

# Overseas travel accident insurance claims services

Leveraging Sedgwick's extensive global network, we offer claims services for incidents occurring in Asia, Oceania, the Americas, Europe, Africa and the Middle East. For theft or damage to personal belongings, we conduct thorough investigations, including verifying police reports and interviewing involved parties. In injury, sickness or death claims, with consent from the insured or their family, we obtain necessary documents from the police, public prosecutor's office or medical institutions. However, local laws or other circumstances may sometimes hinder document submission. For liability claims, we perform onsite inspections, interview relevant parties, provide expert advice on damage assessments and liability, and connect clients with local lawyers as needed.






